



Update from Luton

"Luton Council has been proud to host a series of successful Learning Open Days as part of the Families First for Children Pathfinder Wave 2. These events welcomed councils from across the wider region, offering valuable insights into how Luton has implemented the social care reforms. Attendees gained a deeper understanding of our approach through shared resources including single assessment templates, job descriptions, structure charts and presentations. Key colleagues from our Family Help teams—including social workers, family support workers, team managers, deputy heads of service, and LCPPs—actively participated, sharing honest reflections on our journey. The feedback has been overwhelmingly positive, and we're pleased to have supported sector-wide learning through open dialogue and collaboration. Our peers expressed appreciation for the transparency and practical support provided. We're pleased to have had the opportunity to share our journey and contribute to sector-wide learning and improvement".

Luton also attended the DCS priorities event in July to share their journey with a focus on data. Following this it was agreed that a regional network for practice and data leads should be established to provide a platform for regional collaboration, working through common issues, support and sharing plans and practice. TRANSITIONS

The first Eastern Region ADASS & ADCS Transitions Event on 3rd July brought together senior leaders and practitioners across children's and adult services to ignite a region-wide commitment to better transitions for young people moving into adulthood. This launched the groundwork for cross-service collaboration that we hope will improve not just the pathways, but the experiences of young people as well as their families and carers as they navigate this pivotal phase. The following recommendations will be taken forward:

- Regional Transitions Conference
- Develop a Regional Protocol for Preparation for Adulthood and Transitions
- Regional learning and development of Transitional Safeguarding

ANTI-RACIST PRACTICE

On Friday 16/05/2025, the first Eastern Region Anti-Racist Practice Conference took place in



Stevenage. The event was designed for leaders in Children's Services to take a monumental step forward in anti-racist practice activism and officially launch the Eastern Region Anti Racist Practice Pledge. The Pledge is a collaborative effort co-developed and committed to by all 11 local authorities in our region.

Over 200 senior leaders from across our local authorities came together to listen, reflect, share, be challenged, and commit to meaningful change. The day was not just about

dialogue, but about action—ensuring we move forward with purpose and accountability.

Our Regional Anti Racist Leadership Forum was created following this event to drive Anti-Racist Practice across the region. The second meeting is taking place on 22 September 2025.

Monitoring Compliance with DfE Agency Rules

The Department for Education (DfE) has introduced new rules to improve the stability and quality of the child and family social worker workforce. These rules aim to:

- Strengthen relationships between social workers and families,
- Reduce overreliance on agency staff, and
- Create a more sustainable and cost-effective workforce.

The Eastern Region is actively monitoring compliance using first-quarter DfE data. Our workforce project team already has a well-established data collection system and has been working collaboratively under a **Memorandum of Cooperation** for several years. These new rules provide an opportunity to explore cross-regional collaboration.

Key Dates

1st October 2025: Full compliance with the DfE rules is expected.

CARE LEAVERS

The Regional Care Leaver project is gaining momentum with the appointment of a Project Lead, Gemma Coxen and the establishment of a regional Care Leavers forum who have worked with the Regional Leaving Care Network to coproduce the priorities for the project which are:

- EET & Travel Support
- Support for Care Leavers who are parents
- Adult eligibility and transitions
- Health of Care Leavers
- Support for Care Leavers in custody

Currently a regional diagnostic is being undertaken of local offers to establish a baseline for the region, identify good practice and highlight opportunities for collaboration.

COMMISSION EAST

Strategic Projects & Programme Activity

Commission East is currently managing over 15 projects, including:

- Practice Principles: Co-developed with providers to align values and expectations across the region. A working group is being formed to finalise these principles.
- Workforce Development: Exploring regional training pathways to support and develop the residential workforce.
- Data Insight & Sufficiency Tools: A regional sufficiency dashboard using the 903 data was demonstrated to support placement analysis across the region.

Provider Engagement & Market Collaboration

The Residential Providers Event held in June was a major success, fostering dialogue between LAs and providers. Feedback was synthesised into an action plan covering:

- Strengthening communication channels
- Improving quality assurance
- Enhancing placement planning
- Streamlining referral processes
- Fostering shared learning and trust

Commission East is developing and regional engagement planner that will help create transparency and align engagement activity with providers across the region.

Practice Development & Steering

The Practice Steering Group continues to drive initiatives such as:

- Development of the Eastern Region Placement Request Form, now being piloted in LiquidLogic.
- Creation of a One Page Profile to embed child voice in placement decisions.
- Coordination of Edge of Care workshops to share the good practice across the region. Essex lead the first session which focused on their DBIT service. Norfolk are leading one in October on their New Roads model please follow the link to book your space

Eastern Collaborative Children's Residential Network

The Eastern Collaborative Children's Residential Network (ECCRN) is a 3 monthly forum for exchanging knowledge, good practice, challenges, resources and information. All Registered Managers of all homes are invited to be collaborative members.

The ECCRN is integral to this project collaboratively supporting Residential Child Care practice. We have our own space and will use it for a variety of purposes.

SEND

For 2025-26 there has been a significant increase in funding from the Department for Education for the Regional Improvement & Innovation Alliance funding for SEND which means there are more opportunities for collaboration.

To support the delivery additional governance and oversite has been put in place with the establishment of a Regional SEND Strategic Steering Group and SEND Leadership Network. The existing support networks will continue to meet and an additional SEND Quality Assurance Community of Practice has been established.

What is the Inclusion Community of Practice?

As part of the Regional Improvement and Innovation Alliances (RIIAs) Programme for 2025/26, DfE have asked Improvement East to establish an Inclusion Community of Practice for the Eastern Region, with the purpose of supporting and accelerating progress towards greater inclusion in mainstream education.

How will it be delivered?

The Eastern Region Inclusion Community of Practice will be facilitated by Improvement East via the 2025/26 RIIA grant, and all activities will be co-produced and delivered in partnership by regional colleagues.

Who should attend?

The Inclusion Community of Practice invites participation from all 11 LAs in the Region. LA Inclusion leaders and practitioners, Health and Parent-Carer representatives are invited to join.

Regional SEND Workforce Training

A programme of regional training has been developed for colleagues in response to the SEND Workforce Survey conducted earlier this year and is fully funded through the RIIA. The offer includes:

- Leading Change Programme delivered by Staff College
- Online Legal Training delivered by Bevan Brittan
- The SEN Apprenticeship Programme that has been developed in the Southeast.

Regional Targeted SEND Support Offer

Improvement East is delighted to launch a new Regional SEND Support Offer for 2025/26. It aims to leverage regional expertise, peer-to-peer collaboration, and DfE funding to improve outcomes for children and young people with SEND. The approach focuses on tailored support for Local Authorities to address their specific priorities and challenges.

The Regional SEND Support Offer sits alongside several initiatives to assist Local Authorities in the region and is fully funded as part of the 2025/26 RIIA Grant. The support offer complements these activities and focuses on what can be done within individual local authorities on a topic of their choosing.

Packages of support are available, led by a team of experienced consultants with the aim of providing support to LAs seeking to make swift improvement in an area of their choice. Packages are fully funded and could be arranged as a one-off whole day workshop through to a longer piece of up to 4-5 days.
